

KKR Income Opportunities Fund Declares Monthly Distributions of \$0.125 Per Share and

Announces Quarterly Investor Call Date

New York, NY, (October 9, 2017) — KKR Income Opportunities Fund (the "Fund") (NYSE: KIO) today announced its monthly distributions of \$0.125 per common share, payable on the dates below. Based on the Fund's initial public offering price of \$20.00 per share and current share price of \$17.96 (as of its close on October 6, 2017), the distributions represent an annualized distribution rate of 7.5% and 8.4% respectively (calculated by annualizing the distribution amount and dividing it by the IPO share price or current price, as the case may be).
